Description: Perfume-free and dye-free light duty lotion hand cleanser for regular use to remove general dirt and grime.

Method of Use: Apply 1 dose to dry hands. Rub in well and rinse thoroughly with clean running water. Wipe dry with disposable paper hand towels.
